**How to book:** Please complete the Online Registration Form or email [tours@getontrack.com.au](mailto:tours@getontrack.com.au) with deposit payment of **\$1,250.00** per person.

**Deposit Payments:** Deposit payment of **\$1,250.00** per person should be paid by credit card or electronic funds transfer (EFT).

**Deposit Transfers:** Deposit payments can be transferred to a future **French** tour, provided you notify us no later than **90 days** prior to the first day of the original tour. Deposit transfers must be utilised within 2 years of the original booking. Only one Deposit Transfer will be permitted. Should you fail to utilise your deposit within 2 years of the original booking, your deposit will be forfeited. Otherwise, Deposit payments are non refundable or redeemable for cash.

**Balance Payments:** The balance of your fare will become due **90 days** prior to the first day of the tour. We will invoice you the balance due.

**Cancellation policy:** All cancellations or alterations must be received in writing to [tours@getontrack.com.au](mailto:tours@getontrack.com.au)

- Between **0-89 days** prior to tour departure – 100% of total fare.

**Travel insurance:** **ONTRACK** is not responsible for individual's travel insurance. We strongly recommend you take out travel insurance.
